### SWANSON, NAVAL SECRETARY, DIES AT RAPIDAN CAMP

Member Of Roosevelt Cabinet Since 1933 Succumbs To Hemorrhage

PRESIDENT PAYS TRIBUTE

Leader Also Served As Senator 23 Years And Virginia Governor

WASHINGTON (AP)—Claude A. Swanson, 75-year-old secretary of the Navy, died today at his Rapidan camp in the Shenandoah National Park in Virginia. The Navy was advised it resulted from a cerebral hemorrhage yesterday.

He had been in the camp more than a month, resting and convalescing after his return from a member of the Roosevelt Cabinet since 1933. Swanson followed in the Navy post the same precepts which guided him as chairman of the Senate Naval Committee—striving always to keep the American Navy on the cutting edge of strength in world armaments.

Illness prevented much attention to detail and he left actual direction of the Navy Department largely to Assistant Secretary Charles Edison, who, with Admiral William D. Leahy, chief of operations.

Edison himself was ill for several months this spring, but returned to his duties at the Navy Department on June 1.

On Swanson's death, Edison automatically became acting secretary. The widow, Mrs. Lillie K. Swanson, was at the bedside. Her stepson is Douglas Dean Hall and other immediate survivors are a brother, Henry C. Swanson, of Swanton, Vt., and two sisters, Misses Salie H. and Alma B. Swanson of Swanton, Vt.

Behind Swanson's services in the Cabinet lay a long record of fisheries work. He was secretary of the United States Fish Commission and governor of Virginia for four years.

President Roosevelt, the first to announce Swanson's death, said he was "greatly distressed" at the news.

## Ram Seeks A New Home After 3-Month 'Torture' On Local 'Sheep Ranch'

Owner Fined And Ordered To Dispose Of Entire Flock Of Ewes

A ram that has been "tortured" for the last three months by a halter around his horns, according to a sheep agency at the Society for the Prevention of Cruelty to Animals, found sanctuary today in the animal shelter of the Westchester Sheep Humane Society.

The owner, Anthony Mangone, resident of Mount Pleasant Avenue and operator of a "sheep ranch" at Palmer and Rockland Avenues, Mamaroneck, was fined \$10 by Judge Patrick J. Hughes in village police court this morning.

The ram was brought against Mangone by Jacob Werner, special agent for the SPCA of New York City, whose assistance was asked by Agent Harry Maynard of the Westchester Sheep Humane Society.

Mr. Werner said that the maximum fine of \$50 on each of two counts he imposed on Mangone.

Judge Hughes, however, imposed only \$5 fines on each count, one relating to the ram and the other to maintaining unsanitary conditions in the pen, which quarters five ewes as well as the ram.

The ram had been tied so tightly around the animal's horns that it would draw up in rain and sun, Mr. Werner said.

Mangone said he tied up the ram after it had twice escaped from the pen and batted passersby.

The SPCA agent further charged that the pen was watched for two days and that while Mangone had placed a pail of water in it, the first animal to drink had overturned the pail and the other animals were without water until the following afternoon at 6 o'clock, when Mangone returned.

## DEATH ENDS FIGHT BETWEEN HORSES

Furious Midnight Battle Shatters Serenity Of Mt. Calvary Cemetery

A furious battle at midnight between two horses in Mount Calvary Cemetery, West White Plains, ended early today in the death of one of the animals.

The fight started late last night in an enclosure on the cemetery property where the horses were kept.

The mad pawing and snorting of the enraged animals were so loud they attracted attention to the scene.

There they saw the beasts engaged in battle, snorting and stomping, shattering the usual serenity of the graveyard.

The animals reared and struck each other with their iron-shod hooves and the elder of the two, a 12-year-old, was rapidly losing ground.

It was forced to the brink of the embankment by its foe which, with one final lunge, sent the tottering horse over the edge and into the water.

When attendants reached the spot, the vanquished animal was foundering helplessly in the water, its leg broken.

Michael Kette, superintendent of the cemetery, summoned Patrolman Theodore Newman of the Greenburgh Town Police, who dispatched the scene with his revolver.

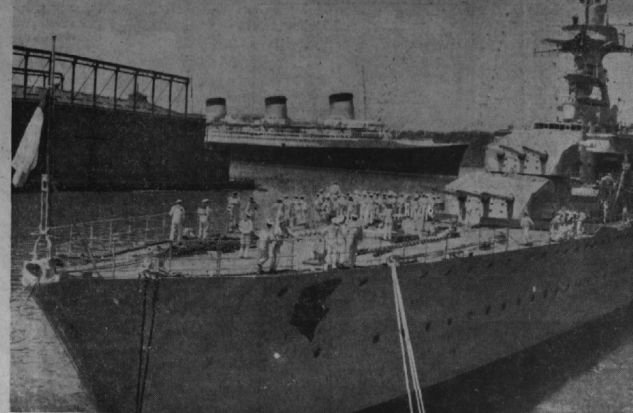

## BARRICADE PARKS IF TOLLS INVAID, BLEAKLEY HINTS

### Extreme Step To Bar Outside Motorists Suggested by County Executive

### LASHES OUT AT MOSES Westchester Has Been 'Kicked Around Enough By State', Official Says

Westchester may take the extreme step of barricading its parkways at the County line against motorists from outside the County if "certain forms" are not returned to the County from the State by July 15, County Executive William P. Bleakley hinted broadly in a talk before the White Plains Lions Club yesterday.

"I feel very strongly about this question," the County Executive declared, "because I think Westchester has been kicked around enough by the State."

Mr. Bleakley named no particular person in his talk but asserted that the State is "kicking around" the County by not returning the tolls. He believed, however, that the State will return the tolls by July 15.

Mr. Moses, head of the New York City Park Department, president of the Long Island Park Commission and chairman of the State Board of Parks, is expected to return to the County on August 6.

Mr. Moses has on two distinct occasions within the past two weeks appeared before County Executive Bleakley. It would be a "double toll" because the imposition of tolls by the County, Mr. Bleakley declared, would not be retaliation but merely the "justice" on all sides.

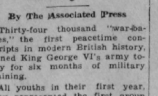

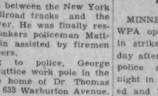

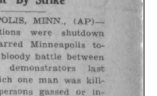

Meanwhile, Donald Fendler, father of the boy, waits at the camp at the foot of the mountain, "trying to get the water in the canteen still a little above zero."

The 67-year-old old-time mountaineer who runs the state's Camp Katahdin, said he had seen the track to the base of the slide started. It was "only faintly, however," that Don, small for his age, could survive a fall down the precipice.

District Forestry Supervisor Sees Slim Chance To Find Him Alive

## MISSING SINCE MONDAY

Rye Amateur Operator Gets Message With Ray Of Optimism

MILLISNOCKET, ME. (AP)—Hope virtually was abandoned today for a young boy who disappeared on Mt. Katahdin, a mile-high rock strewn wilderness four days ago.

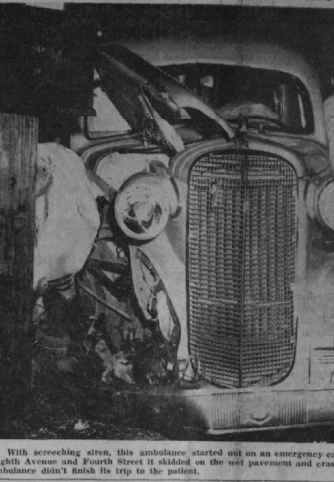

## FATE OF LENDING BILL DOUBTFUL

### Senate Economy Bloc Seeks To Make Additional Cuts In Measure

FATE OF—SEN. HARRY WASHINGTON (AP)—The Senate's bipartisan economy bloc, which opposed victory which stipulated \$500,000,000 from the administration's \$2,000,000,000 spending bill, sought today to make additional reductions and send the measure to a doubtful fate in the House. With Republicans working hand in glove with economy-minded Democrats, the Senate last night threw out President Roosevelt's \$500,000,000 super-highway program by a vote of 42 to 38 and then turned down a proposal to let the Reconstruction Finance Corporation buy up to \$500,000,000 worth of railroad equipment and lease it to the railroads. The vote on that was 42 to 38. Members of the coalition confided they had eliminated the measure from the legislative process. They considered the most objectionable. They planned to press their veto, however, with their drive to knock out a proposed \$100,000,000 authorization to the export-import bank for financing American exports. While crowd galleries listened to the turbulent Senate debate, House Democrats met in caucus and adopted a show-down on the question of whether they would support the lending measure and the administration's accompanying bill to increase the States Housing Authority from \$600,000,000 to \$1,000,000,000.

## Former Coach At Bellows Saved Many From Death In Washington Avalanche

Bellows High School in Mamaroneck, which ended in tragedy when all of the climbers perished in an avalanche of snow, were contained in newspaper clippings received here today.

The clippings were sent to the Daily Times by James H. McGuinness, former resident of the Rye Neck section, now a resident of Olympia, Wash. Mr. McGuinness was one of the survivors of the party from death.

The annual climb by the college students was one of the reasons Mr. McGuinness did not return East this summer as his vacation plans originally called for Mr. McGuinness said.

One of the 22 survivors, W. C. Munnacher, professor of botany at Cornell University, credited the preliminary planning of the climb leaders, including Mr. McGuinness, with having saved the entire expedition from death when the avalanche swept down the party.

## BOY MEETS DEATH WHILE EMULATING FEATS OF TARZAN

### Eastchester Youth Killed In 40-Foot Fall From Lofty Tree Hut

Joseph McLaughlin, 13, was killed yesterday while attempting to emulate the feats of his movie screen hero, Tarzan. He climbed to a lofty tree-hut on Club Way, Eastchester, slipped and fell 40 feet to the ground crushing his skull against a boulder at the base of the tree.

The discovery of the youth's body, clad only in a loin cloth, brought to an end an intensive search, reported missing at 8 P. M. Thursday by his parents, Mr. and Mrs. Joseph McLaughlin, of 150 Park Drive, Eastchester. The youth had been sought by searching parties that combed the densely wooded areas in the vicinity of his home through the rain all yesterday.

Eastchester police and firemen, a contingent of 30 Boy Scout state troopers and the police of seven neighboring states were enlisted in the hunt before the body was discovered by the missing youth's older brother, Edwin, 17, and Robert Gaines, 17, of 68 Sunnyside Street at 4:15 P. M.

## WPA DISMISSALS GOING FORWARD

### 75 Percent Of County Workers To Be Made By Aug. 1, Grattan Says

About 75 percent of the WPA dismissals will have been made by Aug. 1, Harold Grattan, regional director, said today. Dismissal of the 3,300 WPA workers who have been continually employed on county projects for 18 months or more has been staggered so as to disrupt projects as little as possible, Mr. Grattan said. For this reason some workers are lucky enough to gain two or three weeks extra work beyond Aug. 1. All the dismissals of the July quota will be made before Aug. 15.

WPA supervisors are faced with a complex problem of finishing projects which would be damaged by suspension. Grattan explained today for after Aug. 1 the payrolls must be cleared of workers whose 18-month work period terminates in August. However, under present ruling, there will be constant turnover of employment contracts until November, he said.

Most home relief bureaus have not yet received the names of the dismissed workers. This, Grattan says, is due to the avalanche of clerical work which is being done on the state office in Albany since the dismissals began three weeks ago.
