What's It All About?

No. 1—Nine Proposals by GEORGE McCULLOUGH

Editor appearing below within parentheses is not Mr. McCullough but is content by the Editor.

November 5 might be called "The most important election day in 20 years."

On that day, New York State voters will decide the fate of a proposed new Constitution which, if adopted, will have a profound effect on the lives of all its citizens for years to come.

No less than 37 different proposed amendments will await the "yes" or "no" of John and Alice Voter. They are the fruit of five months of labor by the first Constitutional Convention in 32 years—the eighth in New York State history.

Not that a ballot containing 37 varieties of proposals will confront them. That was abandoned out of the question.

The convention wisely took the middle course, it split up its offering into six different questions. It leaves that line-up-in view of the complexity of almost every question involved will mean a big job for John and Alice Voter.

This series is intended to give an idea of what these nine questions are all about.

John and Alice can read the revised constitution in full if they want it. It's a fair bet they won't. It would mean wading through 3000 words of legal language.

Seven or eight newspaper editions would be required to print it all. Copies of the amendments in full may be obtained on request from the Westchester County Board of Elections, Court House, White Plains, or an application to your election district.

It goes without saying that the voter who waits until he closes the curtains of the voting booth, won't be able to do more than guess at what that row of questions at the top of the machine means—even if he should take the time to struggle through the fine print.

Each man to be convinced in such telegraphic brevity that they give only a hint of the vital changes they propose.

The most mooted questions are presented separately. Even at these there had to be a general verdict.

Most amendments embracing nearly 5000 words from the present constitution.

That will be No. 1—Which includes all the proposed amendments not offered separately. Most of these are changes on which there was little or no disagreement in the convention. They are designed principally to improve the present Constitution by striking out obsolete material, clarifying its wording, getting it up to present-day conditions.

Not more than eight or 10 of 15 changes are regarded as of importance to disagreement. In this group, however, are a few amendments which many a voter may be misled, misled in with others he will want to see go through.

F will have to decide which outweighs the other—good or bad—and on that basis, vote "yes" or "no" on Amendment No. 1.

The amendments are:

- No. 1. The "everything-but" Amendment.
No. 2. Legislative apportionment.
No. 3. Grade Crossing.
No. 4. Housing.
No. 5. Judiciary.
No. 6. Labor Bill of Rights.
No. 7. Proportional representation.
No. 8. Health Insurance and social welfare.
No. 9. New York City transit unification.

Tomorrow's article will hit the high spots of Amendment No. 1.

GOECKLER TERMS HARBOR DREDGING PLAN 'ESSENTIAL'

Hearing Set Tomorrow On Larchmont Project; Public Dock Facilities Improved

Drinking of the Larchmont harbor will be termed "essential" in report submitted today by Mayor Harry E. Goeckler of Larchmont to Mayor C. W. Ball, of the United States Engineers Office.

A public hearing is to be held on the project at 11 A. M. tomorrow in the Municipal Building in Larchmont.

Arguments for and against the project will be made, and the project will be recommended to the Board of Engineers.

Mayor Goeckler discussed various details of the proposed plan of harbor with the result that the village in connection with the harbor.

"Due to the shoaling of the harbor from surface drainage," he said at one point, "the water depth has decreased over a large area of the harbor with the result that the mooring grounds for boats of all draughts have been shifted many hundreds of yards out into deeper and more exposed water of the sound, with resultant deterioration of mooring and servicing boats using the harbor."

"It can fairly be stated that if carefully planned dredging is not done within the near future Larchmont Harbor will lose its former great value as a yachting center and refuge point from storms because the level of the anchorage basin is becoming so shallow that it will be extremely difficult to find the available mooring area will become so reduced as to force boats into unprotected waters or into other ports."

"At present," the report continued, "there are no public dock facilities in Larchmont and the proposed improvement would afford facilities for citizens, wishing to purchase and use craft with small draughts, if the dredging work is completed within the village with suitable boathouses and landing with adjoining spaces for parking automobiles."

Mayor Goeckler pointed out that property values in the vicinity of the harbor would eventually become depressed because of the lack of a harbor, and that this would be a serious loss to the community.

CHAMBERLAIN FOLLOWS HIS CROSS BORDER; CHAMBERLAIN LAUDS ROOSEVELT PEACE PLEA

President's Appeals Swayed Europe, He Says

CRITICS RAP HIM

LONDON, Oct. 3 (AP)—Prime Minister Chamberlain today acclaimed the contribution of President Roosevelt to last week's negotiations which averted a European war.

"The voice of the most powerful nation in the world" spoke across the sea to sway Europe's statesmen to ways of peace, declared Chamberlain in his defense in a press conference Commons of the Munich four-power accord for the dismemberment of Czechoslovakia.

"The brave Minister angrily tossed back cries of 'shame!' at his critics and announced an immediate \$30,000,000 loan for dismemberment of Czechoslovakia.

"The prayers of millions were answered by the Munich pact, Chamberlain declared.

"The Prime Minister replied to a bitter denunciation of his bargain with the dictators by Lord Duff Cooper, who quit Saturday and first lord of the Admiralty and who broke into bitter sobbing when he declared that the Munich terms were 'a my dream'.

Chamberlain paid tribute to President Roosevelt and to his fellow signatories of the Munich agreement, Reichsfuehrer Hitler and Premier Mussolini, in a radio broadcast.

"The messages of President Roosevelt, \$30,000,000 and yet so generously made, showed the true voice of the most powerful nation in the world could make itself heard across 2,000 miles of ocean and sway the minds of men in Europe," said Chamberlain.

"The 10,000,000 pound (\$50,000,000) loan announced by Chamberlain is a third of the amount asked by Prague, he disclosed. The grant is an additional 20,000,000 pounds (\$100,000,000) will be considered later, he said.

"Points To Hitler Concessions" The Premier went at length into an effort to show that Hitler's concessions were not made in vain.

REVISED CONSTITUTION

WHAT'S IT ALL ABOUT? No. 2.—The "Everything But" Amendment

(Matter appearing in parenthesis is not by Mr. Macauloch but is comment by the editor.)

Amendment No. 1 "Shall the proposed amendments to the Constitution AMENDING THE CONSTITUTION GENERALLY, submitted by the Constitutional Convention, EXCEPT THOSE SUBMITTED SEPARATELY, as Amendments No. 2 to 8 inclusive, be approved?"

Four dozen proposed amendments are wrapped up in this single package on which the voter must decide "yes" or "no," Nov. 8.

Even though the bulk of its provisions are conceded improvements, there are several important changes which stirred heated convention dispute.

It will take careful weighing of the contents of this amendment, to decide whether Good outweighs Bad or Bad outweighs Good.

HOME BUILDING: Powers of cities expanded—not so much as home rule advocates had hoped for, but special districts affecting schools, recreation and extension systems, courts, colleges, too, given home rule, larger villages will get it later.

The amendments do not interfere in any substantial manner with the increased powers of home rule given Westchester under its new county charter which takes full effect on the first of next year.

LOCAL FINANCES: Provisions aimed at curbing the spending spree of the past, by tapering off debt money over the next few years.

STATE FINANCES & TAXATION: The State's financial set-back, extension of tax power limited. Legislature will take more of a hand in the next session. Salaries of public employees not their pensions may be taxed. Good for business men. Undistributed profits may not be taxed.

EDUCATION: Legislature may provide for transportation of children at any school—public, parochial, private.

SOCIAL SECURITY: State's responsibility to provide for its needy and dependent. Health, for education and support of its children, too, is written into Constitution. Way cleared for broad unified state program of social welfare.

AGRICULTURE: The present 12-year limitation on leases of farm lands is repealed. Municipal UTILITY PLANTS: Guaranteed right to a "fair return" for benefit of all the taxpayers of the municipality.

CONSERVATION: Reformation continued as a state policy, but the mandatory 15-year, \$100,000 program, is repealed.

LEGISLATURE: Ineligibility of federal civil or military officials is repealed. The old bar to members accepting civil appointments is partially let down. Good news for legislators hereafter they'll get greatly their fair share of one round trip a session.

SUFFRAGE: Legislature may provide for statewide election. Signature-identification of all voters required, to be retained for two years. Equal representation for men and women on party committees provided.

DEPARTMENTAL RULES: All which affect the public are centrally filed promptly published. PUBLIC AUTHORITIES: Restricted.

Prominent Residents Support Proposal to Improve Harbor

NO OPPOSITION VOICED

There wasn't any doubt but that the park would be jammed to its capacity by game time, insuring an early start for the Yankees at a gate of 23,800 seats.

PARIS, Oct. 5 (AP)—The Senate today voted to grant Premier Edouard Daladier's cabinet power to govern France by decree until new powers already approved by the chamber of Deputies.

The Senate's vote was 206 to 4. The Chamber had voted the decree powers by 231 to 78, with 204 abstentions after a stormy all-night session in which the premier met much more opposition than in the previous debate on approval of the four-power pact of Munich.

The Chamber approved that accord for dismemberment of Czechoslovakia to save Europe's peace by 525 to 75.

Daladier did not pin the life of his cabinet on the Senate vote since his demand for decree powers was secured of easy acceptance.

"When the decree is published in the official journal, probably tomorrow, the Daladier Government will have broad, almost undefined powers to rule the nation until Nov. 15."

Such powers were sought to grapple with the economic and financial confronting France. Daladier came into office last April 19 with similar powers, but they expired July 31.

Only by a "strong combination" of appeals to patriotism and shrewd official trading did Daladier keep Socialists from casting their 137 votes against him.

He was forced to cut the term of the decree power from Dec. 21 to the accepted Nov. 15, to prompt the chamber publicly that he would respect People's Front socialist reforms and agree to call Parliament into session about Nov. 15, so the Cabinet would have chance of passing next year's budget by decree.

One group in Chamber cordoned was that the former Socialist Premier Edouard Daladier to agree to take, some Socialists in his premier, to permit the more Leftist Party to keep close watch on the decree powers.

The Socialists, by abstaining rather than voting against the cabinet, kept alive the hopes that they support the government. But they sent silent after Daladier's speech and some Rightists deputies cheer.

Asked whether foreign agents had increased their activities in this country, Mr. Roosevelt said he believed there was no marked increase of present, although there had been during the last two years.

Foreign activities are scheduled to go on trial in New York Oct. 24 in charges of being operated in a foreign espionage plot.

The chief executive disclosed the spy problem earlier this week with Lester K. Born, U. S. attorney in New York.

Surf Casting Poor, But Flounder Take Locally Is Good

If you are torn between the desire either to surf cast or to hunt you had better choose the latter.

Fishing has not been going so well for anglers on the surf casting route as along the fresh water back bay channels. Those who tried surf casting last weekend met with disappointment.

For you local anglers the reports on flounder fishing here are encouraging and this is particularly true right here in the waters of the Sound from Manhattan down to New Rochelle.

Unprecedented numbers of large flounders have come to hook right here in our own Sound. Local black fishermen have not fared so well, however, but I look for some excellent angling for this species shortly, continuing until the real weather sets in.

The long hoped for run of mackerel did not materialize, either, and the reason remains a mystery to me. It is now 10 years since this fish has come into the Sound areas. Too bad, because they make for lots of sport and provide a succulent meal.

Fish Production Mounts
The State Conservation Department advised that the 1938 fish production of the hatcheries shows a decided increase. A total of 47,602,000 eggs of various species were planted in lakes, ponds and streams, many of them in our local county waters. This is to be commended and goes to prove that the department is advancing the sport.

Native Birds Are Scarce
The woodcock season is now open and they are again doing the season on pleasant, grouse, and deer woods. Two weeks to run before they become legal kill. The flight of the timber-doodle is on but few migrating birds are being seen here.

Native birds are with us but they remain few and far between and do not offer the upland game hunter many targets. A bird here and there discourages the wildfowler who is obliged to tramp through miles of woods in order to locate these erratic fliers.

However, I can give this assurance, the hunt from the northern latitudes is now in progress, and reports from these areas indicate a plentiful supply of woodcock. When they begin to drop in those areas you who choose the thrush barrel should have sufficient fun to believe that all this sport will be continued with the winter now in our local cover.

EXTRA COURT OF APPEALS UPHOLDS STOWELL IN OUSTER CASE

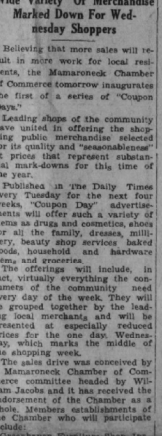
